Whereas, The Superintendent of Police, Highway Safety Petrol, Raigad 01. Range has submitted a proposal on 14.04.2024 that Yashwantrao Chavan Expressway (Mumbai-Pune Highway) having a total length of 94 km. and on this stretch km. 35.500 Up to Km. 52,000 is the ghat area (Borghat). Presently, the speed limit on this expressway is 100 kmph for the flat section and within the ghat area the speed limit is 50 kmph. Practically, the mentioned speed limit within the ghat area is very low for light vehicles and due to the steep gradient on the Pune to Mumbai channel while travelling at a speed of 100 kmph from the flat area while entering the Ghat stretch lowering the vehicle speed as low as 50 kmph for the Light Motor Vehicles causes undue hardship to vehicle drivers which is inter alia reason for increase in number of accidents within the stretch.

Whereas, taking into account the submissions and feedbacks during the meeting held on 15/04/2024 at office of the Addl. Director General of Police (Traffic), MS, Mumbai of officials from MSRDC office Pune, Transport Department, IRB INFRA Development Office, Superintendent of Police, Highway Police Raigad Zone, Police Inspector, Highway Police Panvel Division, In-charge Police Inspector Borghat TAP, Chief Draftsman Transport Engineering Department on speed limit at Borghat considering the Yashwantrao Chavan Expressway road design and widening of roads in ghat section it has been unanimously decided to amend speed limitations in Borghat section of the Yashwantrao Chavan Expressway for Light Motor Vehicles.
